SYNOPSIS OF KALKASKA COUNTY LIBRARY FEASIBILITY STUDY JUNE, 2006

After many months of deliberation with assistance from several community members, The Kalkaska County Library Board commissioned a feasibility study of an ideal plan for library expansion. The conceptual drawing included 15,000 square feet and was proposed to be built on county property on Island Lake Rd. using green construction techniques. The projected cost for the project was \$2,500,000. Sixty-six county residents were interviewed to assess the opinions of the public regarding this plan. Following is a summary of the results of the feasibility study which includes compilation of the interview data.

Positive Factors:

- There is a firm commitment to library services in the county. All
 respondents felt the library was an important part of the community and
 most thought the current programs and services were very satisfactory.
- Respondents indicated 100% that a larger library for the County is needed.
- There was an indication that citizens would financially support an expanded library, but not to the extent needed for this proposal.
- Local foundations expressed openness to assisting with a Capital Campaign for a larger library.
- Green construction was seen as a good value by most respondents, and the Kresge Foundation would be a potential funding source for planning of such a facility.

Negative Factors:

- There is not significant support for the Island Lake building site.
- There is not a clear suggestion of an alternate site.
- The proposed cost of \$2,500,000 is much higher than the community is able to support.

• The continued wrangling over the Kaliseum creates apprehension in the community for a similar project.

• A history of lack of cooperation among community members and apathy for growth may be a stumbling block to a library expansion project.

It is recommended that the Library Board with continued assistance of community members review alternate plans, especially concentrating on sites in the downtown area. Remodeling and/or adding on to an existing structure will be well received by the community. A Capital Campaign will be the most acceptable method of funding a new facility with a maximum project price of \$1,500,000.

Projections indicate that \$650,000 to \$700,000 could be raised in local gifts over a three to five year period. This would require significant contributions from 5% of local residents. It is possible to secure the remaining funds from fundraisers, smaller local contributions and support through grants from governmental units and private foundations.

The continued involvement and encouragement of the project by the Friends of the Kalkaska Library is imperative. This organization can provide the leadership of a Capital Campaign.

A proposed library expansion must have broad based community support; active and involved volunteers; a well planned budget and timeline; a well designed action plan; and a focused and committed vision. Every effort should be made to help County leadership and residents see that a new library will be a catalyst for economic, educational, cultural and recreational growth of Kalkaska County.

Funding:

As you can see from the proposal package, the Kalkaska Library Board is committed to building a new facility with a capital campaign. They do not want to use taxes to build, but will want taxpayer support for operation. Currently county property owners pay about \$12 a year for each \$100,000 of property value (\$50,000 sev). The increase for operation could go to \$25 or \$35 per year.

Thank you for the opportunity to work with you on this fine project. I have appreciated getting to know each of you, members of the Friends and so many great people who live in Kalkaska County.

I would like to assist you as you move forward with a library expansion plan. Depending on the route you now take, there are a few different ways I can help you. Of course I would be eager to be an advisor for your capital campaign, but I can also facilitate the process leading up to the campaign.

I expect that you may pursue the next level of planning with a collaboration of several local organizations and governmental bodies. As the feasibility study report indicates, your continued success will depend on a well designed action plan with a focused and committed vision. I feel that the steps you now take will frame this plan and set the tone for its future development and success.

The proposed timeline that I gave to you in January is still quite accurate. This would indicate that for the remainder of this year you create a more detailed plan. In the winter of 2007 you could begin the lead grant and gift process. A capital campaign could begin in the spring or summer of 2007 and continue for a year. Of course you know that working for a renewal/increase of your operating millage will need to be addressed at that point. With a successful millage and progress in the capital campaign, it is possible that you could be serving patrons in a new facility by 2010!

This timeline may be extended if you decide to pursue a grant from the Kresge Foundation for green construction planning. This will add several months to the planning stage but may be very well worth the wait.
