As of February 28, our total fund balance was \$784,224, a decrease of \$12,521 from the previous month. This agrees pretty well with our calculated Total Bank Balance, of \$786,096.

We are earning approximately \$1,025 a month interest on our various holdings.

Penal Fines are still running lower than we even estimated with our conservative budget. February's fines were only \$4,404. The penal fines are now \$10,000 behind budgeted target.

There was about \$545 in Tax Revenue from PILT and Forest taxes; we won't see our millage money until May or Jun.

Turning to Expenditures, our only concern is that we have red ink in 717 State Unemployment Tax, 719 Health and Dental Insurance. We estimate those costs when budgeting, and if we estimate wrong, it eventually makes us have to amend our budget. Spending is ahead of target in 740 Books and 831 Legal, but under control since they are just against a "targeted" amount for this point in the year.

We continue to move non-millage amounts of fund balance from 271 to 472 as they become available.
