# 6. Treasurer's report / approval of expenditures:

Total Library Fund Balance at the end of March was \$890,175.68, about \$11,500 less than the previous month. The Total Bank balances are in close agreement, at \$891.896.61.

We earned about \$619 in interest last month. The SBR does not show our year-to-date interest yet in any of the three funds, but as I track this month by month, we have earned \$194.17 in 271, \$307.21 in 471, and \$1,436.56 in 472, for a YTD of \$1,937.94. Our predicted quarterly total is about \$1,615, so we are ahead of that. We're WAY ahead on

472, but a little behind in 271, and about on track on 471. Penal fines continue to be low, with March being only \$3,161 for a YTD total of just \$10,800 against a \$70,000 budget.

Regarding other revenues, we expect to receive \$217,606.86 in tax revenues. (See 271 balance sheet "Taxes Receivable") We were given the figure \$221,700 for our <u>budgeted</u> amount, so it seems we will have a shortfall there as well, of about \$4,100.. I would like to hold appropriation of balance to the budgeted \$59,000 or reduce it if possible. We need to continue to exercise restraint in spending, until we can get a millage increase passed.

I have discovered a possible higher interest rate on CDs with an outfit called **Michigan Schools and Government Credit Union**, which has branches all around the Detroit metro area. Their CD interest rates are just about twice what 4Front offers, for instance their 12 month rate for a minimum \$500 is 0.7%, and 4 Front's is only 0.3% (0.45% on \$100,000 jumbo). Their rate for a 36 month CD is 1.15%, while 4 Front is at 0.5%. I approached them recently and they seem to be willing to deal with us on-line if we want to buy CDs. We have a jumbo \$100,300 maturing in early November, and a \$15,000 maturing in early December.
